Mayor Smart opened the meeting in prayer; then led the Pledge of Allegiance.

Keith Merritt motioned to adopt the minutes to the January 12, 2026, Regular Meeting as read, Pam Chanler seconded. Motion carried.

Richard Davis motioned to add Act 461, Playground Equipment to the agenda under New Items. John Langford seconded. Motion carried unanimously.

Richard Davis introduced proposed Ordinance No. 163 titled AN ORDINANCE PROHIBITING DOOR-TO-DOOR SALES AND PEDDLING WITHIN THE TOWN LIMITS OF THE TOWN OF SIBLEY, LOUISIANA, PARISH OF WEBSTER, STATE OF LOUISIANA WITHOUT A PERMIT AND REGISTRATION ISSUED BY THE TOWN OF SIBLEY; PROVIDING FOR THE SEVERABILITY OF THE DIFFERENT SECTIONS HEREOF AND THE REPEAL OF ALL OR PARTS OF ALL CONFLICTING ORDINANCES AND PROVIDING IN CONNECTION THEREWITH and motioned to set a public hearing for Monday, March 9, 2026 at 6pm at the Sibley Town Hall during the March 2026 Regular Meeting. John Langford seconded. Motion carried.
