The Sibley Town Council met in regular session on Monday, March 9, 2026, at 6pm at Sibley Town Hall.

Members present were Mayor Robert Smart; Aldermen: Wayne Bolton, Pam Chanler, Richard Davis, John Langford and Keith Merritt.

Mayor Smart opened the meeting in prayer; then led the Pledge of Allegiance.

Keith Merritt motioned to adopt the minutes to the February 9, 2026, Regular Meeting as read, Richard Davis seconded. Motion carried.

Richard Davis motioned to adopt the minutes to the February 16, 2026, Special Meeting as read, Wayne Bolton seconded. Motion carried.

No New Items were added to the agenda and there were no Public Comments.

Wayne Bolton motioned, seconded by Pam Chanler, to enter the Public Hearing for proposed Ordinances No. 152-A and 163, motion carried.

After some discussion, Richard Davis motioned to exit the Public Hearing and re-enter the March 2026 Regular Meeting. Pam Chanler seconded. Motion carried.

Wayne Bolton motioned to adopt proposed Ordinance No. 152-A titled AN ORDINANCE PROHIBITING EIGHTEEN WHEELED TRACTOR TRAILER TRAFFIC ON STREETS WITHIN THE TOWN OF SIBLEY, LOUISIANA, EXCEPT ON U.S. HIGHWAY 371 AND LOUISIANA HIGHWAY 164, WITHOUT A PERMIT; PRESCRIBING PENALTIES FOR VIOLATIONS; AND PROVIDING FOR RELATED MATTERS. John Langford seconded. Motion carried.

Pam Chanler motioned to participate in the Louisiana Department of Justice's Community Outreach program to provide the community with necessary information on a variety of topics. John Langford seconded. Motion carried.

Assistant Fire Chief Richard Davis gave the February 2026 Activity Report for the Sibley Volunteer Fire Department.

No one was present to give the February 2026 Activity Report for the Sibley Police Department.

The Board acknowledged receipt of the February 2026 Financial Report.

The mayor gave a report on the women's inmate crew that has begun working in town, the Playground project and Love the Boot Week in April.
