John Langford motioned to adopt Resolution No. 2017-12 requesting assistance from the Webster Parish Police Jury to do ditching on SE 5th St. Alan Myers seconded. Motion carried.

Larry Merritt motioned to adopt Resolution No. 2017-13 requesting assistance from the Webster Parish Police Jury for installation of a culvert and ditching on NE 4th and Perritt. John Langford seconded. Motion carried.

Chief Jeremy Robinson gave a monthly report on the Sibley Police Department.

Larry Merritt gave a monthly report on the Sibley Volunteer Fire Department.

Mayor Williams reminded the council about the LMA District A meeting on June 28, 2017, which Mayor Williams as LMA District A Vice President will host. This will be the last year for Mayor Williams to host. He will be elected for the LMA Second Vice President seat.


Mayor Williams also reminded the council of the LMA Convention in July.
