Robert Smart motioned to adopt Resolution No. 2022-11 authorizing Mayor Jimmy Williams to enter into a Lease Purchase Agreement with Government Capital Corporation for the purpose of financing a police patrol unit. Helen Chanler seconded. Motion carried.

Helen Chanler motioned to adopt Resolution No. 2022-12, increasing water base rates beginning on the July billing, as follows:
