

June 14, 2016

The Sibley Town Council met in regular session on Tuesday, June 14, 2016 at 6pm in the Sibley Town Hall Meeting Room.

Members present were Mayor Jimmy Williams; Aldermen Doyle Chanler, John Langford, Larry Merritt and Alan Myers. Richard Davis was absent.

Mayor Williams opened the meeting in prayer; then led the Pledge of Allegiance.

Larry Merritt motioned to adopt the May 17, 2016 Regular Meeting minutes as read, Doyle Chanler seconded. Motion carried.

No new items were added to the agenda.

Alan Myers motioned to go into the Public Hearing for proposed Ordinance No. 126-M titled AN ORDINANCE ADOPTING THE BUDGET FOR THE TOWN OF SIBLEY, LOUISIANA FOR THE FISCAL YEAR ENDING JUNE 30, 2017 and for the proposed 2016 Amendment to Ordinance No. 114A titled AN ORDINANCE ESTABLISHING COMPENSATION AND BENEFITS TO MUNIICIPAL ELECTED OFFICIALS AND MUNICIPLA EMPLOYEES FOR THE TOWN OF SIBLEY, LOUISIANA, AND PROVIDING IN CONNECTION THEREWITH. John Langford seconded. Motion carried.

John Langford motioned to end the Public Hearing and resume the June 2016 Regular Meeting. Larry Merritt seconded. Motion carried.

Doyle Chanler motioned to vote on proposed Ordinance No. 126-M titled AN ORDINANCE ADOPTING THE BUDGET FOR THE TOWN OF SIBLEY, LOUISIANA FOR THE FISCAL YEAR ENDING JUNE 30, 2017. John Langford seconded, roll call vote:

Alan Myers motioned to adopt Resolution No. 2016-10 requesting assistance from the Webster Parish Police Jury in the filling of pot holes on Jones, NE 5th, NW 2nd, SE 4th, SE Johnson, Tharpe and Weatherton. Larry Merritt seconded. Motion carried.

Doyle Chanler motioned to adopt Resolution No. 2016-11 requesting assistance from the Webster Parish Police Jury for asphaltting over the culvert at SE 4th St. and Natchitoches. Alan Myers seconded. Motion carried.

Larry Merritt gave the monthly activity report for the Sibley Volunteer Fire Department.

Officer Cody James gave the monthly activity report for the Sibley Police Department.

Under Oral Correspondence Mayor Williams updated those in attendance on a grant for the Early Warning System and the National Night Out in October. He also reminded the aldermen about the LMA District “A” meeting and the LMA Convention. Everyone was asked to keep Alderman Doyle Chanler in their prayers due to medical issues.

Alan Myers motioned to adjourn, Doyle Chanler seconded. Motion carried.
