The Sibley Town Council met in regular session on Monday, May 9, 2022 at 6pm in the Sibley Town Hall Meeting Room.

Members present were Mayor Jimmy Williams, Aldermen: Wayne Bolton, Helen Chanler, Alan Myers and Robert Smart. Richard Davis was absent.

Mayor Williams opened the meeting in prayer; then led the Pledge of Allegiance.

Robert Smart motioned to accept the minutes to the April 11, 2022 Regular Meeting as read, Helen Chanler seconded. Motion carried.

There were no New Items or Public Comments.

Wayne Bolton motioned to enter into a Public Hearing for proposed Ordinance No. 152 titled AN ORDINANCE OF THE TOWN OF SIBLEY, LOUISIANA, PROHIBITING HEAVY VEHICLE TRAFFIC ON SPECIFIC STREETS WITHIN THE TOWN OF SIBLEY, AND PROVIDING FOR A PENALTY IN VIOLATION THEREOF, Helen Chanler seconded. Motion carried.

Alan Myers motioned to adjourn the Public Hearing, Robert Smart seconded. Motion carried.

Robert Smart motioned to consider proposed Ordinance No. 152 titled AN ORDINANCE OF THE TOWN OF SIBLEY, LOUISIANA, PROHIBITING HEAVY VEHICLE TRAFFIC ON SPECIFIC STREETS WITHIN THE TOWN OF SIBLEY, AND PROVIDING FOR A PENALTY IN VIOLATION THEREOF with a vote, Helen Chanler seconded. Motion carried.

Ordinance No. 152 was adopted.

Robert Smart introduced proposed 2022 Amendment to Ordinance No. 126-R titled AN ORDINANCE ADOPTING THE BUDGET FOR THE TOWN OF SIBLEY, LOUISIANA FOR THE FISCAL YEAR ENDING JUNE 30, 2022, proposed Ordinance No. 126-S titled AN ORDINANCE ADOPTING THE BUDGET FOR THE TOWN OF SIBLEY, LOUISIANA FOR THE FISCAL YEAR ENDING JUNE 30, 2023, and proposed Ordinance No. 147-E titled AN ORDINANCE ESTABLISHING COMPENSATION FOR MUNICIPAL EMPLOYEES FOR THE TOWN OF SIBLEY, LOUISIANA, AND PROVIDING IN CONNECTION THEREWITH and to set a Public Hearing for each during the June 13, 2022 Regular Meeting at 6pm at Sibley Town Hall, 345 North Main, Sibley, LA. Wayne Bolton seconded, motion carried.

Wayne Bolton motioned to adopt Resolution No. 2022-07 authorizing Mayor Williams to complete and submit an application for a grant for funds from the Community Water Enrichment Fund Program (CWEF). Alan Myers seconded. Motion carried.

Wayne Bolton motioned to adopt Resolution No. 2022-08 authorizing Mayor Williams to complete and submit an application for a grant for funds from the Local Government Assistance Program (LGAP). Alan Myers seconded. Motion carried.

Robert Smart motioned to adopt Resolution No. 2022-09 authorizing Mayor Williams to secure and execute a Servitude to Drain agreement with Crichton Properties, LLC. Alan Myers seconded. Motion carried.

Wayne Bolton motioned to appoint the Minden Press Herald the official journal for the Town of Sibley for July 1, 2022 – June 30, 2023. Helen Chanler seconded. Motion carried.

Alan Myers gave the Sibley Volunteer Fire Department April 2022 Activity Report.


