The Sibley Town Council met in regular session on Monday, May 10, 2021 at 6pm in the Sibley Town Hall Meeting Room.

Members present were Mayor Jimmy Williams, Aldermen Wayne Bolton, Helen Chanler, Richard Davis, Alan Myers and Robert Smart.

Mayor Williams opened the meeting in prayer; then led the Pledge of Allegiance.

Richard Davis motioned to accept the minutes to the April 12, 2021 Regular Meeting as read, Wayne Bolton seconded. Motion carried.

Robert Smart motioned to add the Police Department to the agenda under new items. Wayne Bolton seconded, motion carried with unanimous vote.

Proposed 2021 Amendment to Ordinance No. 126-Q titled AN ORDINANCE ADOPTING THE BUDGET FOR THE TOWN OF SIBLEY, LOUISIANA FOR THE FISCAL YEAR ENDING JUNE 30, 2021 was introduced. Richard Davis motioned to set a public hearing for 6pm on Monday, June 14, 2021 during the June 2021 Regular Meeting. Helen Chanler seconded. Motion carried.

Proposed Ordinance No. 126-R titled AN ORDINANCE ADOPTING THE BUDGET FOR THE TOWN OF SIBLEY, LOUISIANA FOR THE FISCAL YEAR ENDING JUNE 30, 2022 was introduced. Robert Smart motioned to set a public hearing for 6pm on Monday, June 14, 2021 during the June 2021 Regular Meeting. Wayne Bolton seconded. Motion carried.

Proposed Ordinance No. 147-D titled AN ORDINANCE ESTABLISHING COMPENSATION FOR MUNICIPAL ELECTED OFFICIALS AND MUNICIPAL EMPLOYEES FOR THE TOWN OF SIBLEY, LOUISIANA, AND PROVIDING IN CONNECTION THEREWITH was introduced. Helen Chanler motioned to set a public hearing for 6pm on Monday, June 14, 2021 during the June 2021 Regular Meeting. Alan Myers seconded. Motion carried.

Alan Myers made a motion to take Chief Jeremy Robinson's recommendation and hire Chris Miller as a full-time officer. Helen Chanler seconded. Motion carried.

Richard Davis motioned to adopt Resolution No. 2021-08 declaring the 1997 Chevrolet, 1 ton dually as surplus property and authorizing Mayor Williams to advertise for bids with a minimum bid of \$2,000. Wayne Bolton seconded. Motion carried.

Richard Davis gave the April 2021 monthly activity report on the Sibley Volunteer Fire Department.


There was no report giving for the Sibley Police Department.

The mayor spoke of attending the Municipal Day at the Legislature, the Hwy 164 overlay project, the Wastewater grant update and the opening of the Splash Pad.


Alan Myers motioned to adjourn, Richard Davis seconded. Motion Carried.
