The Sibley Town Council met in regular session on Tuesday, May 9, 2017 at 6pm in the Sibley Town Hall Meeting Room.

Members present were Mayor Jimmy Williams; Aldermen Doyle Chanler, John Langford, Larry Merritt, Alan Myers and Robert Smart.

Mayor Williams opened the meeting in prayer; then, led the Pledge of Allegiance.

Robert Smart motioned to adopt the minutes to the April 11, 2017 Regular Meeting minutes as read, Doyle Chanler seconded. Motion carried.

No new items were added to the agenda.

Robert Smart introduced proposed Ordinance No. 126-M-1 titled AN ORDINANCE ADOPTING THE BUDGET FOR THE TOWN OF SIBLEY, LOUISIANA FO THE FISCAL YEAR ENDING JUNE 30, 2017.

Larry Merritt introduced proposed Ordinance No. 126-N titled AN ORDINANCE ADOPTING THE BUDGET FOR THE TOWN OF SIBLEY, LOUISIANA FOR THE FISCAL YEAR ENDING JUNE 30, 2018.

John Langford introduced proposed Ordinance No. 147 titled AN ORDINANCE ESTABLISHING COMPENSATION FOR MUNICIPAL ELECTED OFFICIALS AS WELL AS THE TOWN CLERK FOR THE TOWN OF SIBLEY, LOUISIANA, AND PROVIDING IN CONNECTION THEREWITH.

A public hearing was set for proposed Ordinance No. 126-M-1, proposed Ordinance No. 126-N and proposed Ordinance No. 147 for Tuesday, June 13, 2017 at 6pm during the regular monthly Council Meeting at the Sibley Town Hall, 345 N. Main St., Sibley, LA.

Larry Merritt motioned and Alan Myers seconded, to adopt Resolution No. 2017-07 authorizing Mayor Jimmy Williams to proceed with the development of the LCDBG application. Motion carried.

Robert Smart motioned and Alan Myers seconded, to adopt Resolution No. 2017-08 adopting the Citizen Participation Plan / Citizen Complaint Procedure and appointing Sherry McCann as Citizen Complaint Officer for compliance with the LCDBG Program. Motion carried.

Larry Merritt motioned and Doyle Chanler seconded, to adopt Resolution No. 2017-09 adopting a Procurement Policy for compliance with the LCDBG Program. Motion carried.

Doyle Chanler motioned and Robert Smart seconded, authorizing Mayor Jimmy Williams to proceed with the procurement and selection of professional services for the purpose of assisting in the development of the LCDBG application and implementation of the project. Motion carried.

Larry Merritt gave a monthly report for the Sibley Volunteer Fire Department. Report reflected 0 calls for May 2017.


Chief Jeremy Robinson gave a monthly report for the Sibley Police Department.
