

**ORDINANCE NO. 144
AMENDMENT NO. 1**

AN AMENDMENT TO ORDINANCE NO. 144, REPEALING THAT PORTION OF ORDINANCES 3, 3A, AND 115 IN CONFLICT HEREWITH AND TO PROVIDE FOR UPDATED FINES AND PENALTIES FOR SPEEDING, MOVING VIOLATIONS AND NON-MOVING VIOLATIONS FOR THE TOWN OF SIBLEY, LOUISIANA AND PROVIDING IN CONNECTION THEREWITH:

BE IT ORDAINED AND ENACTED by the Mayor and Board of Aldermen of the Town of Sibley, Louisiana, in regular session duly convened on February 9, 2016, as follows, to-wit

SECTION I.

The following violations:

1. Improper Passing	\$155.00 + \$20.00
2. Improper Lane Usage	\$150.00 + \$20.00
3. Following Too Close	\$155.00 + \$20.00
4. Illegal Turn	\$150.00 + \$20.00
5. Failure to Signal	\$140.00 + \$20.00
6. Stop Sign Violation	\$155.00 + \$20.00
7. Failure to Yield to Emergency Vehicle	\$205.00 + \$20.00
8. Railroad Crossing Obedience to Signal	\$155.00 + \$20.00
9. Failure to Stop at Railroad Crossing	\$155.00 + \$20.00
10. Littering	\$170.00 + \$20.00
11. Child Not Restrained	\$155.00 + \$20.00
12. Open Container	\$230.00 + \$20.00
13. Two Headlights Required	\$125.00 + \$20.00
14. Tail Lights Required	\$125.00 + \$20.00
15. License Plate Light Required	\$125.00 + \$20.00
16. Failure to Dim High Beams	\$125.00 + \$20.00
17. Window Tint	\$125.00 + \$20.00
18. Driving Under Suspension	\$275.00 + \$20.00
19. Allowing Unlicensed Person to Drive	\$135.00 + \$20.00
20. No Proof/No Insurance	\$145.00 + \$20.00
21. Careless Operation	\$300.00 + \$20.00

A. Fine and penalty for any other moving violations:

The fine and penalty for any other moving violations not specified hereinabove shall be \$155.00 + 20.00 together with court cost and ticket fees together with an imposition of a jail sentence up to but not in excess of 30 days.

B. Speeding:

Whoever shall be found guilty of the offenses of speeding within the town limits of the Town of Sibley shall be ordered to spend up to but not in excess of 30 days in jail together with a fine as follows:

| 1. Up to ten (10) miles over the posted speed | \$155.50 + \$20.00 |
| 2. Up to fifteen (15) miles over the posted speed | \$165.50 + \$20.00 |
| 3. Up to twenty (20) miles over the posted speed | \$185.50 + \$20.00 |
| 4. Up to twenty-five (25) miles over the posted speed | \$205.50 + \$20.00 |
| 5. Up to thirty (30) miles over the posted speed | \$255.50 + \$20.00 |

SECTION III.

All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION IV.

If any provision or item of this ordinance or the application thereof is held invalid such invalidity shall not affect any other provisions, items or applications of this ordinance or of the original ordinance, which could be given effect without the invalid provisions, items or applications and to this end the provisions of this ordinance are hereby declared severable.

SECTION V.

This ordinance shall be effective on March 1, 2016.

This Ordinance was introduced at the January 12, 2016 Regular Meeting, a public notice was published in the Minden Press Herald on January 14, 2016 and a Public Hearing was held at the February 9, 2016 Regular Meeting.

Public Notice was posted on January 14, 2016 at the Sibley Town Hall and printed in the Minden Press Herald on January 19, 2016.


A Public Hearing was held on February 9, 2016 at 6pm during the February 2016, Regular Meeting held at the Sibley Town Hall Meeting Room.
