

**ORDINANCE NO. 147-E**

**AN ORDINANCE ESTABLISHING COMPENSATION FOR  
MUNICIPAL ELECTED OFFICIALS AND MUNICIPAL  
EMPLOYEES FOR THE TOWN OF SIBLEY, LOUISIANA,  
AND PROVIDING IN CONNECTION THEREWITH**

BE IT ORDAINED AND ENACTED by the Mayor and Board of Aldermen of the Town of Sibley, Louisiana, in regular session duly convened on June 13, 2022 as follows, to-wit:

**SECTION I.**

Effective July 1, 2022, the compensation and salary of the Mayor, Board of Aldermen, Chief of Police and Town Clerk is hereby set, as required by La. R.S. 33:404.1 and 404G as follows:

Mayor	\$18,000 annually
Alderman	\$6,000 each annually
Police Chief	\$23,000 annually
Town Clerk	\$45,900 annually

**SECTION II.**

All ordinances or parts of ordinances in conflict herewith are hereby repealed.

**SECTION III.**


If any provision or item of this ordinance or the application thereof is held invalid such invalidity shall not affect any other provisions, items or applications of this ordinance or of the original ordinance, which could be given effect without the invalid provisions, items or applications and to this end the provisions of this ordinance are hereby declared severable.

**SECTION IV.**


This ordinance shall be effective on July 1, 2022.

Public Notice was posted on May 10, 2022 at the Sibley Town Hall.


A Public Hearing was held on June 13, 2022 at 6pm during the June 2022 Regular Meeting held at the Sibley Town Hall Meeting Room.
