

ORDINANCE NO. 3-B

AN ORDINANCE PRESCRIBING SPEED LIMITATIONS FOR MOTOR VEHICLES
OPERATING ON THE STREETS AND HIGHWAYS OF THE TOWN OF SIBLEY,
LOUISIANA

Be it ordained by the Mayor and Board of Aldermen of the Town of Sibley,
Louisiana that:

SECTION I.

No person shall operate or drive any passenger vehicle upon the streets or
highways within the Town of Sibley, Louisiana in excess of the following speeds:

- A. 35 miles per hour on Crichton Road within the town limits of the
Town of Sibley.
- B. 35 miles per hour on Jones Street within the town limits of the
Town of Sibley.

SECTION II.

Whoever violates the speed limitations of this ordinance shall be fined according
to the Town of Sibley, Louisiana's fine schedule.

SECTION III.

If any provision or item of this ordinance or the application thereof is held invalid
such invalidity shall not effect any other provisions, items or applications of this
ordinance or of the original ordinance, which could be given effect without the
invalid provisions, items or applications and to this end the provisions of this
ordinance are hereby declared severable.

SECTION IV.


This ordinance shall be effective on February 1, 2010.


This ordinance was introduced during the Regular Meeting on December 8, 2009.

considered and adopted upon the following vote that was taken:

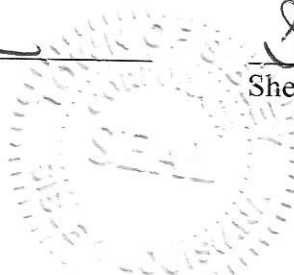

Public Notice was posted on December 9, 2009 and advertised in the Minden Press Herald on December 16, 2009.


A Public Hearing was held on January 12, 2010 at 6pm during the January 2010 Regular Meeting held at the Sibley Town Hall Council Chambers.
