

ORDINANCE NO. 127

AN ORDINANCE AUTHORIZING A RIGHT OF WAY AND SERVITUDE FOR
THE CONSTRUCTION OF A STREET ACROSS THE L&A CORRIDOR AND
SOUTHEAST SIXTH STREET AND TO PROVIDE IN CONNECTION
THEREWITH

BE IT ORDAINED AND ENACTED by the Mayor and Board of Aldermen of the Town of Sibley, Louisiana, in regular session convened on August 12, 2003 as follows, to-wit:

SECTION 1.

Ordinance No. 127 of the Code of Ordinances of the Town of Sibley, Louisiana is hereby adopted to read as follows:

- A. The Town of Sibley is authorized to obtain from L & A Trail, Inc. a Servitude of Passage and Right of Way for the construction of a street across the L & A corridor at Southeast Sixth Street within the city limits of the Town of Sibley.
- B. The town is authorized to make the necessary financial arrangements for Construction and installation of the said street in accordance with the Servitude.
- C. Mayor Larry Merritt be and he is hereby authorized and empowered to Execute for and on behalf of the town a servitude and agreement in accordance with the agreement and servitude, a copy of which is attached hereto as Exhibit "A".

SECTION 2.

All ordinances or parts of in conflict herewith are hereby appealed.

SECTION 3.

If any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect any other provisions, items or applications of this ordinance or of the original ordinance, and if any items or provisions of the original ordinances are held in violation, the application thereof shall not affect any of the provisions of this ordinance, and to this end, the provisions of this ordinance are hereby declared severable.


This ordinance was read and considered as a whole and on motion of Andy Fish, seconded by Wayne Bolton, was passed and adopted by the following vote:
