

TOWN OF SIBLEY

IT SHALL BE UNLAWFUL FOR ANY PERSON, PERSONS, COMPANY OR CORPORATION, TO DIG, TRENCH, RESHAPE, OR OTHERWISE DISTURB ANY PORTION OF THE TOWN OF SIBLEY STREET RIGHT - OF - WAYS SO AS TO PLACE ON TOP, OR BURY BENEATH THE GROUND, PIPE, WIRE OR ANY OTHER MATERIALS UNTIL THE FOLLOWING CONDITIONS ARE MET:

- [1] A MEETING WITH THE TOWN OF SIBLEY COUNCIL OR MAYOR TO INFORM THE TOWN OF THE NATURE AND EXTENT OF THE WORK
- [2] SECURE A PERMIT IN WRITING FROM THE MAYOR GIVING PERMISSION FOR THE JOB
- [3] AN AGREEMENT TO PUT THE RIGHT - OF - WAYS BACK IN THEIR ORIGINAL ~~STATE~~ ^{CONDITION}
- [4] TO PLACE A DEPOSIT WITH THE TOWN OF SIBLEY EQUIVALENT TO THE COST OF RE-DOING THE RIGHT - OF - WAY
- [5] THE DEPOSIT TO BE RETURNED TO THE PERSON, PERSONS, COMPANY OR CORPORATION WHEN THE JOB IS COMPLETED AND IT IS ASCERTAINED BY THE TOWN COUNCIL THAT THE RIGHT - OF - WAY IS IN AS GOOD ~~SHAPE~~ ^{CONDITION} AS IT ORIGINALLY WAS JUST PRIOR TO THE COMMENCEMENT OF WORK, OR BETTER
- [6] THIS DEPOSIT TO BE USED BY THE TOWN OF SIBLEY TO RE-WORK THE RIGHT - OF - WAYS IF THE PERSON, PERSONS, COMPANY OR CORPORATION FAILS TO PUT THE RIGHT - OF - WAY BACK IN ITS ORIGINAL ~~SHAPE~~ ^{CONDITION} OR BETTER WITHIN THIRTY (30) DAYS AFTER COMPLETION OF THE JOB.

FAILURE TO ABIDE BY SECTIONS [1]. [2], [3] or [4] shall carry a penalty of \$25.00 PER DAY WORK IS CARRIED ON, OR THEEQUIVALENT IN A JAIL SENTENCE.
